

Resolution of 5th December 2017, which allocates scholarships for incoming staff mobility from partner countries under the Erasmus+ KA107-2016 Programme

Once the selection process established in the **call for applications Erasmus+ KA107-2016 scholarships for staff from partner countries** (Mobilities during the 2016-2017 and 2017-2018 academic years, always before 31st July 2018)

I HEREBY RESOLVE:

First. Provisionally award scholarships from funds of the European Commission to the staff from partner countries listed in the annex attached to this decision in accordance with the criteria set out in the call for applications approved by the *Comissió de Relacions Internacionals i Política Lingüística* of 28th November of 2016.

Second. The final award of these scholarships will not occur until the staff is effectively registered at the Universitat Autònoma de Barcelona and has completed all the procedures required in accordance with the conditions of the call.

() The grants will be paid to the beneficiaries by the Universitat Autònoma de Barcelona (UAB), according to real arrival and departure dates. These payments are subject to the regulations of the UAB and the Spanish Law, which implies a 24% of tax reductions on the final amount received.**

Countries with a double taxation agreement: Beneficiaries awarded with an Erasmus+ KA107 grant should add a certificate from their home Tax Agency to avoid a tax of the 24% of the total amount of the grant.
