

**Resolution of 5th July 2017, which allocates scholarships for teaching staff mobility from partner countries under the Erasmus + KA107-2016 Programme**

Once the selection process established in the call for applications Erasmus+ KA107-2016 scholarships for teaching mobility from partner countries (Mobilities during the 2017-2018 academic year, always before 31<sup>st</sup> July 2018)

I HEREBY RESOLVE:

First. Provisionally award scholarships from funds of the European Commission to the teaching staff from partner countries listed in the annex attached to this decision in accordance with the criteria set out in the call for applications approved by the *Comissió de Relacions Internacionals i Política Lingüística* of 28<sup>th</sup> November 2016.

Second. The final award of these scholarships will not occur until the teaching staff is effectively registered at the Universitat Autònoma de Barcelona and has completed all the procedures required in accordance with the conditions of the call.


