#### **Prerequisites**

Required language level: German C1.2 CEFR (Common European Framework of Reference)

At the beginning of the course students should be able to:

- Understand different types of spoken German, using fairly complex constructions, about general topics from a wide range of subject areas, reflecting the most commonly used styles or registers. (CEFR-FTI B2.4)
- Express themselves in different types of spoken German on general topics in different subject areas. (CEFR-FTI 2.3)

# Learning objectives

The aim of this course is to consolidate the listening comprehension skills necessary for interpreting and to enhance oral expression skills in German needed in interpreting.

At the end of the course students should be able to:

- Understand different types of spoken German about a wide range of subject areas and able to discern variation in accents, styles or registers. (CEFR-FTI C1.3)
- Express themselves in different types of spoken German on a wide range of subject areas, employing styles and registers. (CEFR-FTI C1.2)
