#### The doctoral thesis

The doctoral thesis must include, at least, an introduction to the topic of study, the objectives to be attained, a description of the research conducted, a discussion of the results obtained, conclusions and biblio graphy.

In addition, there may be as many annexes as considered necessary. The thesis may contain published or unpublished articles, both in the main body and in the annexes.

The title page of the thesis should state that it is a doctoral thesis and contain the title and subtitle, where appropriate, the names of the supervisor and academic tutor, the PhD programme, the department, the university and the year when the thesis was deposited. The volume number should be indicated if the thesis is divided into volumes.

The thesis may be written in any of the official languages of Catalonia or in one of the languages commonly used for scientific communication in the field of clinical and health psychology.

The thesis deposit is carried out online, on this page

Remember that you have to record your thesis deposit no later than 10 days before the meeting of the Academic Committee of the Programme in which the deposit will be resolved. Confirm with the Department secretary the calendar of meetings.

Using the online deposit tool, you should also upload the following documents, which are **specific** to the programme:

- CVs of members of the panel of examiners who do not belong to the department (single file)
- Doctoral student's Activities Document (DAD)

# If you are applying for the international doctoral research component

• CVs of the two expert consultants for the international doctoral research component: covering the last 5 years and including publications, projects and theses supervised.

<u>In the case of a thesis as a compendium of publications or a thesis that</u> includes articles

 A digital copy of the form requesting permission to submit the thesis as a compendium of publications, plus the resolution on this request, which should contain the complete references to the articles in the compendium (in APA, 7th edition format), the journal's impact factor, the area it belongs to and its ranking within that area

- documents accrediting that the articles have been published or accepted
- If the thesis contains non-open-access articles, the body of the thesis shall include the reference to the publication, given in current APA format. The full article shall be provided to each member of the examining board, in digital or paper format and jointly with the thesis, but separately from the thesis document itself.
- whenever a co-authored article (submitted or accepted for publication or already published) is included in the thesis: the co-authors' agreement form indicating that they have been informed and agree to the article's inclusion in the thesis, and its exclusion from any other thesis.

Contact the Programme Secretary in advance to prepare the deposit documentation (<a href="documentation-colorista">documentation (doc.psico.clinica@uab.cat)</a>.

This programme encourages students to use the compendium of publications format.

### The doctoral thesis as a compendium of publications

The doctoral candidate should appear as at least the first author of the two main articles published in journals indexed in the Journal Citation Reports (JCR). Exceptionally, of the two articles, one may have a shared primary author where (I) the Academic Committee of the PhD Programme has approved a detailed and reasoned justification of the substantial and fair contribution (for example, in the case of multidisciplinary research) of the people sharing the primary authorship and, (II) the article is published in a high-ranking journal (1st or 2nd quartile).

The names of the UAB and the Department of Clinical and Health Psychology should appear in the articles that make up the thesis, through the affiliation of the supervisor, the doctoral candidate and the members of the UAB who participate in the work, as specified below.

Example. Full names of the UAB members taking part in the work. Department of Clinical and Health Psychology Universitat Autònoma de Barcelona

# <u>Procedure</u>

For a thesis as a compendium of publications, you will need to submit the following documents to the Department at least one month before the meeting of the Programme's Academic Committee in which the deposit will be resolved.

- Application for compendium of publications
- Original document (i.e. not a fax or a scanned copy) in which the coauthors, both PhDs and non-PhDs, undertake not to include the works in any other doctoral thesis.

The Academic Committee will notify you by email of the resolution on your application.

Please note that the co-authors of the articles may not form part of the thesis examining board.

#### Please note the following.

It is compulsory to publish doctoral theses online. For this reason, articles which are not published in Open Access mode may not be included in the thesis, due to issues of copyright. Part of the first page of the paper or the DOI may be included, but not the whole paper if the publisher has not authorised this. If the journal is an Open-Access one and the authors or research group have paid the journal to publish the article in Open Access mode, then the whole article may be included in the thesis.

### TDR (Tesis doctorales en Red) and embargo of the thesis

Pursuant to Spanish Royal Decree RD 99/2011, all theses deposited as from 13/02/2012 must be published on the TDR. However, a system is in place to protect against the subsequent publication of the thesis in scientific journals or editorials. At the time of deposit, the PhD student can request a temporary embargo of the thesis for a period of 6 to 24 months, as set out in the thesis-digitisation acceptance document. A report from the thesis supervisor must be provided, giving the reasons for the embargo.
