Once the first selection process established in the 1<sup>st</sup> call for applications Erasmus+ KA171 2024 grants to incoming staff from third countries not associated to the Programme (Mobilities during the 2025-2026, 2026-2027 academic years, always before July 31, 2027 is finished)

I HEREBY RESOLVE:

<u>First</u>. Provisionally award grants from funds of the European Commission to the staff from partner countries listed in the annex attached to this decision in accordance with the criteria set out in the call for applications approved by the *Commission for International Relations and Language Policy on April 3, 2025.* 

<u>Second</u>. The final award of these grants will not occur until the staff is effectively registered at the Universitat Autònoma de Barcelona and has completed all the procedures required in accordance with the conditions of the call.

<u>Third</u>. The mobilities and grants will be subjected to the regulations and restrictions that might be issued by the authorities, in relation to unforeseen and/or emergency situations that may occur.
