

1st Resolution (June 16, 2025), which allocates Erasmus+ KA171 2024 grants for incoming staff mobility from third countries not associated to the Programme

Once the first selection process established in the **1st call for applications Erasmus+ KA171 2024 grants to incoming staff from third countries not associated to the Programme** (Mobilities during the 2025-2026, 2026-2027 academic years, always before July 31, 2027 is finished)

I HEREBY RESOLVE:

First. Provisionally award grants from funds of the European Commission to the staff from partner countries listed in the annex attached to this decision in accordance with the criteria set out in the call for applications approved by the *Commission for International Relations and Language Policy on April 3, 2025*.

Second. The final award of these grants will not occur until the staff is effectively registered at the Universitat Autònoma de Barcelona and has completed all the procedures required in accordance with the conditions of the call.

Third. The mobilities and grants will be subjected to the regulations and restrictions that might be issued by the authorities, in relation to unforeseen and/or emergency situations that may occur.

(**) The Travel amount is calculated depending on the distance between the institution of origin and the institution of destination according to the European Commission's regulations. This amount will only be paid if the person is in the country of their home university before the start of the mobility period and provides proof by submitting a copy of their flight ticket.

It will be needed the signature of an Inter Institutional agreement between the UAB and the University of origin to have exemption of paying taxes.

The grants will be subject to have all the required documents before the end of the cure period.
