(*) Scholarships will be paid to the beneficiaries by the Universitat Autònoma de Barcelona (UAB), according to real arrival and departure dates. These payments are subject to the regulations of the UAB and the Spanish Law, which implies a 24% of tax reductions on the final amount received.

(**)Countries with a double taxation agreement: Beneficiaries awarded with an Erasmus+ KA107 grant should add a certificate from their home Tax Agency to avoid a tax of the 24% of the total amount of the grant.

(***)The amount will depend on the distance between the institution of origin and the institution of destination according to the European Commission's regulations.
