How do we obtain your personal data?

The data is obtained directly from the person concerned and also from people who have requested information from the Fundació Universitat Autònoma de Barcelona, the Universitat Autònoma de Barcelona or entities related to them.

Which personal data do we process?

The data needed for the treatment is included in the following categories¹:

- Identification data.
- Personal characteristics.
- Academic and professional data.

For what purpose we process your personal data?

UAB Languages processes your data in order to communicate and promote the activities and studies of its centre.

Treatment includes profiling or automated or semi-automated decisions based on information about training preferences, academic record and/or professional experience provided by applicants.

How long will we keep your personal data?

Personal data will be kept by UAB Languages until you request their withdrawal or, failing that, for a period of three years.

What is the legitimation for the processing of personal data?

The legal basis for the processing of data is the consent of the person concerned (Article 6.1-A RGD).

Interested parties may withdraw consent at any time without affecting the lawfulness of the processing based on the consent previous to its withdrawal, by sending an email to UAB Languages: proteccio.dades.idiomes@uab.cat.

What recipients may we communicate your personal data to?

The data may be communicated, for the same purpose that it was obtained, to the Fundació Universitat Autònoma de Barcelona, the Universitat Autònoma de Barcelona or entities related to these, as well as competent public bodies in compliance with current legislation.

What international data transfers do we make?

International data transfers are not planned.

What are your rights when you provide us with your personal data?

Anyone has the right to obtain confirmation on whether UAB Languages is processing personal data concerning them or not.

Interested parties have the right to access their personal data and to request the rectification of these when they are inaccurate or, where applicable, request the deletion, inter alia, when the data is no longer needed for the purpose for which it was collected.

In the circumstances provided in Article 18 RGD, interested parties may request the limitation of the processing of their data.

In certain circumstances and for reasons related to their particular situation, interested parties may oppose the processing of their data. UAB Languages will stop processing the data, unless there are compelling legitimate grounds or to exercise or defend any claims.

Under the right to portability, interested parties are entitled to obtain their personal data in a structured and commonly used machine-readable format and transmit them to other responsible parties.

How can you exercise your rights?

By writing a letter to Escola d'Idiomes Moderns Casa Convalescència, SLU, Sant Antoni M Claret, 171, Casa Convalescència – 08171 Barcelona, or by sending an email to proteccio.dades.idiomes@uab.cat.

What are the ways of claiming?

Should you consider that your rights have not been dealt with appropriately, or have been infringed, you have the right to file a prior claim to the UAB corporation's Protection of Rights delegate, at (dpd.corporacio.uab@uab.cat; Av. Can Domènech s/n - Edifici Blanc del Campus de la Universitat Autònoma de Barcelona - 08193 Cerdanyola del Vallès). This claim must be resolved within a maximum period of 2 months from receipt.
