

## **Amendment to the 1st Resolution (May 15, 2026), allocating Erasmus+ KA171 2025 grants for incoming students' mobility from third countries not associated to the Programme**

---

Following the publication of the 1st Resolution (May 15, 2026), which allocated Erasmus+ KA171 2025 grants for incoming students from third countries not associated to the Programme (mobilities to be carried out during the 2026–2027 and 2027–2028 academic years, and in any case before 31st July 2028), this amendment is issued in order to correct errors detected in the personal data of some of the beneficiaries to whom the grant was awarded.

I HEREBY RESOLVE:

First. To provisionally award the grants financed by the European Commission to the students from partner countries listed in the annex to this decision, in accordance with the criteria set out in the Call for Applications approved by the Commission for International Relations and Language Policy on February 19, 2026.

Second. The final award of these grants will not occur until the student is effectively registered at the Universitat Autònoma de Barcelona and has completed all the procedures required in accordance with the conditions of the call.

Third. Mobilities and grants shall be subject to any regulations and restrictions that may be issued by the competent authorities in relation to unforeseen and/or emergency situations that may arise.
