Independent experts call for increased investment to strengthen Europe's research and innovation leadership

More excellent research, impactful innovation and technology scale-ups are needed to make Europe more globally competitive, secure and sustainable. These are among the twelve expert recommendations presented today to the Commission to strengthen Horizon Europe, the EU research and innovation programme, and its successor.

The recommendations have been drafted by an independent group of 15 leading experts chaired by Manuel Heitor, former secretary of state for science, technology and higher education of Portugal. Their report, entitled 'Align, Act, Accelerate: Research, Technology and Innovation to boost European Competitiveness', highlights the European added value of the EU framework programme for research and innovation (R&I), and puts forward twelve recommendations:

1. Adopt a whole-of-government approach to align research and innovation with the EU strategy for competitiveness and a clean, digital economy.
2. Boost Europe's global competitiveness by fostering impactful research, innovation and scale-ups through a stronger framework programme.
3. Deliver European added value via a portfolio of actions focused on competitive excellence, industrial competitiveness, societal challenges and a strong research and innovation ecosystem.
4. Establish an experimental unit to launch disruptive innovation programmes with fast funding options, such as "ARPA-style" initiatives.
5. Strengthen competitive excellence by expanding funding for European Research Council, European Innovation Council and the Marie Skłodowska-Curie Actions to attract top talent.
6. Create an Industrial Competitiveness and Technology Council to enhance industrial research and innovation investment and ensure relevance to strategic autonomy.
7. Form a Societal Challenges Council to address key societal issues, align with EU strategic priorities and engage with philanthropy and civil society.
8. Build an inclusive and attractive EU R&I ecosystem by securing long-term investments, fostering university alliances and encouraging Member States' co-investment.
9. Simplify the programme by reducing administrative burdens, embracing agile funding and streamlining application processes.
10. Develop an innovation procurement programme to stimulate industrial scaling through demand-driven solutions.
11. Approach international cooperation with a nuanced strategy, tailoring partnerships to specific domains and global geopolitical considerations.
12. Optimise dual-use technology innovation by managing civilian and military R&I programmes separately, leveraging benefits for national security and civilian needs.

Strengthening Europe's civil and military preparedness and readiness: Report by Special Adviser Niinistö

Strengthening Europe's preparedness is a matter of urgency. Europe is facing a new reality, marked by increased risk and deep uncertainty. Since the start of this decade, the EU has experienced the most severe pandemic in a century, the bloodiest war on European soil since the Second World War, and the hottest year in recorded history.

Against this backdrop, Sauli Niinistö – former President of the Republic of Finland and Special Adviser to the President of the European Commission – was tasked by President von der Leyen, together with the High Representative for Foreign Affairs and Security Policy (HR/VP), to prepare a report assessing the complex challenges that the EU and its Member States face and to develop recommendations on how to enhance the EU's civilian and military preparedness and readiness for future crises.

The report underlines the need for an ambitious new approach to our preparedness and readiness. To this end, it presents around 80 recommendations for both short-term and medium to long-term actions.

PREFACE

Preparing Europe for a more dangerous world

Security is the foundation on which everything is built

The European Union's security environment has in many ways taken a turn for the worse in recent years. The world is more dangerous and crisis-prone. The continuation of peace cannot be taken for granted and security cannot be seen as a given, as is manifested by the increasing damage caused by climate change. We must be better prepared, not only to survive, but also to thrive in this new reality. This calls for an overhaul of the way we Europeans see the Union's role in keeping us all secure.

The objective of European integration after the Second World War was to create lasting peace among its members. It was seen that only peace and security make development and people's well-being possible. This created a new European spirit and a new idea of cooperation that has taken long steps forward. This is a great achievement of the countries and the community that form today's EU.

Despite all the wars, conflicts and disasters that have taken place in the EU's neighbourhood and beyond, the EU and its Member States have been secure from immediate existential threats since the end of the Cold War.

During the first decades after the Cold War, it became easy to think that security is not something that is a very present concern in our daily lives. Yet, in fact, we need security for everything. This applies equally to individuals, communities, states, and the whole European Union. We cannot see and feel security when we have it, which makes its loss all the more dramatic and painful.

At the start of this decade, Europe has woken up to a new reality. The COVID-19 pandemic was a crisis of a nature and magnitude for which all Member States and the EU as a whole were insufficiently prepared. Russia's full-scale invasion of Ukraine showed that it takes two to maintain peace, but only one to start a war. Russia's invasion also underlined Putin's long-held perception that the West and Western people are weak. Moreover, the increasing damage caused by extreme weather events is forcing Europeans to ask not only how climate change will affect future generations, but also what we need to prepare for today.

The structures, processes and legal basis of the EU have been created over decades without our own security needs at their core. For example, the EU's common foreign, security and defence policies, as well as cooperation on internal security, were all launched in the 1990s when direct threats to the EU were perceived to be at a historic low. What's more, the gravity of the threat of climate change for our livelihoods and way of life had not yet been fully understood.

The optimism of that time stands in sharp contrast to today's security environment. This is increasingly shaped by great power competition and the readiness of authoritarian states to use violence to assert their territorial or political claims. In addition, instrumentalised migration and, for example, disruptions to global supply chains underline the multifaceted nature of threats. We need to make sure our legislation, working methods and tools match the challenges we face. However, at its heart, preparedness is an attitude.

This 2024 CERIS report describes how research and innovation can contribute to **strengthening the EU's resilience in the civil security domain**. It has been prepared within the framework of the Community for European Research and Innovation for Security (CERIS).

The report covers the following **10 topics**, based on the CERIS workshops carried out in 2023-2024:

1. Ensuring Europe's resilience to internal security threats;
2. Combating child sexual abuse online;
3. Bioterrorist attacks by non-state actors;
4. Disinformation, fake news and hate speech;
5. Community policing;
6. Enhanced disaster resilience and risk governance;
7. Technologies for first responders and interoperability;
8. Border checks and travel facilitation at border-crossing points;
9. Control of goods and trade facilitation;
10. Use of artificial intelligence for security purposes.

The sections advocate for a **collaborative, comprehensive and adaptive approach to security**, involving threat and risk assessment, gap and needs analysis and the strategic use of research and innovation. They underscore the significance of EU policies and programmes, recommending measures to improve the uptake of innovation, enhance strategic autonomy through innovation procurement and promote ethical and legal considerations in security research and development.

An EU Compass to regain competitiveness and secure sustainable prosperity



Today, the Commission presents the Competitiveness Compass, the first major initiative of this mandate providing a strategic and clear framework to steer the Commission's work.

The Compass sets a path for Europe to become the place where future technologies, services, and clean products are invented, manufactured, and put on the market, while being the first continent to become climate neutral.

Over the last two decades, Europe has not kept pace with other major economies due to a persistent gap in productivity growth. The EU has what is needed to reverse this trend with its talented and educated workforce, capital, savings, Single Market, unique social infrastructure, provided it acts urgently to tackle longstanding barriers and structural weaknesses that hold it back.

President of the European Commission, Ursula von der Leyen, said: "*Europe has everything it needs to succeed in the race to the top. But, at the same time, we must fix our weaknesses to regain competitiveness. The Competitiveness Compass transforms the excellent recommendations of the Draghi report into a roadmap. So now we have a plan. We have the political will. What matters is speed and unity. The world is not waiting for us. All Member States agree on this. So, let's turn this consensus into action.*"

- EU funding has become increasingly important for the European research ecosystem, as **the share of EU funding compared to alternative funding streams has increased over the years**
- Complementary objectives and perspectives also reflect the richness of the European security ecosystem, often leading to **diversified solutions tailored to addressing the existing operational needs**
- Projects at nearly all times touch upon important political priorities and are in the vast majority of cases aligned with the goals and ambitions set out at the political level
- Development of new, global market segments in which EU companies strive (e.g., in the area of border control, biometrics and identity verification technology). Moreover, stakeholders reported that the funding programmes **contributed to the competitiveness of the EU security market to the rest of the world**
- Continuous research and innovation driven by the European Commission **has effectively contributed to the development of capabilities**

Leaders of the EU's 27 countries have concluded their emergency summit in Brussels to thrash out a new defense plan — at one of the most pivotal moments for the bloc's security since World War II.

After President Donald Trump's efforts to pressure Ukraine to concede to Russia and disengagement of the U.S. from Europe's security, EU leaders broadly agree Europe must rearm, to be able to defend Kyiv — and itself.

While disunity is usually kept behind closed doors, Hungarian Prime Minister Viktor Orbán vetoed the leaders' statement, meaning the final agreement to arm Ukraine was endorsed by the other 26 leaders only.

The five-point agreement, which affirms that there must be no negotiations on Ukraine without Ukraine and commits to providing Ukraine with €30.6 billion in 2025, came after a 1.5-hour discussion with President Volodymyr Zelenskyy.

All 27 endorsed a proposal to dramatically boost defense spending by up to €800 billion across the bloc, using a range of new funding instruments.

What is EU civil security research?

EU civil security research provides innovations, modern technologies and data to governments, EU and national authorities, businesses and researchers, on topics of strategic importance for Europe's security. These range from fighting crime and terrorism, to strengthening external border management, ensuring our cybersecurity, and helping our society get ready for disasters due to climate change.

Under Horizon Europe, the EU's research and innovation programme for the period 2021-2027, EUR 1.6 billion are available for civil security research. For 2021 and 2022 alone, EUR 413.6 million have already been programmed to support these EU policy priorities:

- protection against crime and terrorism;
- effective management of EU external borders;
- a reliable, robust and resilient operation of infrastructures;
- increased cybersecurity; and
- a disaster-resilient society for Europe.




The current research programme builds on past research. Between 2014 and 2020, under the [Horizon 2020 research programme](#), the EU spent around EUR 1.2 billion on 340 R&D projects for civil security, some of which are still ongoing. Many of [the technologies developed under these projects](#) already benefit society. For example:

- The decision tools for **pandemic management** used throughout the EU to contain the Covid-19 pandemic were a direct result of EU-funded security research;
- R&D in the field of disaster resilience led to the setting up of a [pan-European early warning platform](#), used by civil protection authorities for identifying situations arising from extreme weather events, such as **flash floods, storm surges, droughts, wildfires and heatwaves**.





Participación española en CL3 (2007-2023): Excelentes resultados




RETORNOS POR PAÍS




RETORNOS ESPAÑOLES POR TIPO DE ENTIDAD



Introduction

In 2025, the European Commission will put forward a comprehensive proposal for the next long-term budget – the multiannual financial framework (MFF). This includes EU funding providing financial support to hundreds of thousands of beneficiaries, including research and technology organisations, small and medium sized businesses, startups and scale-ups, educational and research institutions, industry clusters, and many others.

Today, EU funding in support of competitiveness is spread over too many overlapping programmes, many of which fund the same thing but with different requirements and difficulties in combining funding effectively, which hinders access to EU funding and limits the impact that the funding can have.

As highlighted in President von der Leyen's Commission's [Political Guidelines](#), as well as in the [Competitiveness Compass](#), the Commission will work on a simpler, more focused and impactful MFF that reflects the European strategic priorities (with the ambition of being an "investment-focused Commission").

The guidelines also announced the creation of a European Competitiveness Fund, as part of the proposal for the next MFF. As set out in the Competitiveness Compass, this investment capacity should channel investment in strategic technologies along the entire investment journey, from research, through scale-up, industrial deployment, to manufacturing – using the power of the EU budget to de-risk and mobilise private investment for our common goals.

The Commission's proposal for the next MFF will be focused on the things that matter most, in areas where the EU can achieve more than Member States acting alone. This requires a careful assessment both of what has worked well in the past and what could be improved in the future. The next MFF will draw lessons from the current budget – notably in terms of simplicity and flexibility, speed and strategic focus.

As an integral part of the process, the Commission is launching a series of public consultations to gather views from all interested parties on the future EU budget. This consultation covers EU funding in support of EU competitiveness. The decision to cluster issues serves to support the preparatory work and does not pre-empt the architecture of future programmes. This questionnaire consists of 3 parts:

Heatwaves, droughts and wildfires

Catalonia has seen a decrease in yearly average number of wildfires and burnt areas due to improved firefighting effectiveness. However, the accumulation of available biomass and the increase in droughts and heatwaves have led to more extreme fire behaviours in recent years. **Sweden** has seen a sharp increase in wildfire activity in recent years, notably in 2014 and 2018. These events were caused by a combination of drought and excessive heat.

This twin will not only focus on exchanging knowledge between the two services developed for different scales (regional and national), but further add value to the accuracy of warnings by considering additional indicators and improving preparedness through an increased forecast horizon (from a week to months ahead).



The **Universitat Autònoma de Barcelona (UAB)** is one of the major public universities in Spain, and it is in Cerdanyola del Vallès, near the city of Barcelona in Catalonia, Spain. 6. Actions which **do not fulfil the ethics requirements** referred to in paragraphs 1 to 4 and are therefore not ethically acceptable, shall be **rejected or terminated** once the ethical unacceptability has been established.

Criptografía

La **criptografía post-cuántica** es una evolución de la criptografía clásica diseñada para resistir ataques de futuros ordenadores cuánticos; se implementa por software en sistemas clásicos y no requiere tecnología cuántica.

En cambio, la **criptografía cuántica**, como la Distribución Cuántica de Claves (QKD), utiliza principios físicos de la mecánica cuántica y suele requerir canales ópticos o espaciales (por ejemplo, satélites) para garantizar seguridad basada en leyes físicas, no en supuestos computacionales.

Proyectos relevantes actuales a la temática

1. Proyecto actual nacional QKD-LEO coordinado por CDTI:

Participación en el desarrollo de tecnologías de distribución de clave cuántica (QKD) en satélites de órbita baja terrestre, enfocándose en la integración de estas tecnologías en plataformas espaciales. Está liderado por SENER.

2. Proyectos con la Agencia Espacial Europea (ESA)

relacionados con identificación de ataques y contramedidas para comunicaciones seguras en sistemas espacio - tierra.

#1 - Fragmentación

- Ámbitos relacionados: **seguridad civil, criptografía postcuántica, criptografía cuántica y temas de espacio** de forma separada y fragmentada.
 - Ejemplo: **criptografía postcuántica** (Hoja de ruta UE 2024), coordinar la transición a la criptografía postcuántica, definir estándares comunes, y asegurar la coherencia y eficiencia de este proceso en toda Europa y además:
 - necesidad **de hibridar criptografías (postcuántica y cuántica)** para conseguir niveles de seguridad superiores, sobre todo en **aplicaciones críticas como comunicaciones seguras gubernamentales o infraestructuras críticas** (es decir, entiendo yo lo que se busca también en Cluster 3).

#2 – Ambigüedad Civil/Dual

- Aunque muchas convocatorias europeas insisten en el carácter "civil" de los proyectos, se observa una creciente ambigüedad al fomentar explícitamente aplicaciones "duales", lo cual genera tensiones entre los objetivos civiles declarados y los intereses estratégicos en defensa.
- Esta dualidad también entra en conflicto con las directrices de algunas universidades, como la UAB, que promueven una investigación orientada a fines exclusivamente civiles y sociales, dificultando así la participación en proyectos con posibles derivadas en seguridad o defensa.





