## Steps to take before registration



### 0. Steps to take before registration

To register for a Master's degree, you need to have pre-registered and been accepted on the course. You can see the pre-registration process for Master's degrees here (<u>Video link</u>). If you do not have a NIU (university identification number) from the UAB, you must obtain it at <u>https://sia.uab.cat</u>, within the Pre-registration option for official master's degrees without a NIU, as it is essential to formalize your pre-registration and registration.

For some degrees you must have paid a pre-registration fee to be able to access the process. This information is available on the website of each Master's degree course.



Registration prepayment: if you have to make a prepayment for your registration please check the dates for doing so on the academic and administrative calendars. To make your prepayment you need to go to the website <u>https://sia.uab.es</u>. Select "Official Masters Registration Prepayment" and enter using your NIU and password.
