Characteristics of the student's progress report:

PLEASE PRESENT: a research presentation for the *Doctoral Seminar of Presentation of Research* ("la Jornada Doctoral de Presentació de Recerques") organized by the Department. The communication needs to be presented in written form and cannot contain more than 5000 words, although larger texts are admitted in case the PhD student plans to submit it to an academic journal (up to the word limit permitted by the journal). Despite the presentation of the written text, the committee evaluates primarily the oral presentation as a conference presentation and not the written text. The paper needs to present partial results of the doctoral investigation, but the committee can make comments about the doctoral research as a whole.

IN THE ANNEXES, please include an updated curriculum vitae and the progress reports of the previous progress examinations.

COVER PAGE (see next page): The cover page should include the student's name, e-mail and ID, the title of the project, the starting date of the doctoral program, the year of the examination (3rd/4th/5th), commitment (full-time or part-time), whether the student writes a thesis by articles, whether the PhD student holds a grant, if so, the reference of the grant, the name(s) of the thesis advisor and the tutor, and the expected end date of the thesis. If the paper is a draft of a research article based on the doctoral research, please include the name of the journal, the norms of publication and indicate whether the paper: has been submitted/is under review/ is accepted for publication/in print. If the paper is a proposal for a conference presentation, please include the name, place and date of the conference.

**!** In the case that the assessment is **not** held in-person, the index of the thesis should be attached with an indication of the sections or chapters that still need to be written/revised.

The PhD advisor(s) should also submit a report, following the template "Model d'informe del director del seguiment anual RD 99/2011 (18/07/2013)", outlining the progress that the PhD student has made and endorsing the student's report.

PUBLIC PRESENTATION DURING EXAMINATION: 10 minutes of presentation of the paper by the PhD-student, followed by 10 minutes of discussion for each member of the evaluation committee, and 5 minutes of reply of the PhD student, with a maximum of 45 minutes per doctoral student.
