The review procedure will be carried out during the second half of June.

The procedure for all the committees will consist of an oral presentation of the PhD student, in which s/he will present the work s/he is doing. In addition, the PhD student should also submit an annual work report where s/he will present the task proposals to be carried out during the following academic year. In this same document, the PhD student will also analyze the degree of achievement of the tasks proposed in the previous year. Finally, the tutor will deliver a report evaluating the doctoral student's work in the last year. For those negative evaluations, there will be a second review process starting from October for all commissions.

During this procedure, and in accordance with the regulations of the doctorate, in exceptional cases (Article 329. Evaluation of the doctoral student), the oral presentation given by the doctoral student about the work carried out during this academic year 2025-26, can be substituted by the presentation of the aforementioned annual work report, or by other non-face-to-face communication that each line of research might decide.

In addition, all the documentation of the annual evaluation and review procedure, as well as the individual evaluation reports of the doctoral students, can be signed electronically by the members of the monitoring committees of each line of research.
