## Information for collaborating institutions in External Academic Internship (curricular)

The curricula of the Bachelor degrees of the Faculty of Biosciences offers to its students the possibility to take as elective subjects, 12 credits of an academic internship in entities.

The new regulation framework that regulates the external academic internship of university students (Spanish "Real Decreto" 592/2014, of July 11, published in the BOE of July 30, 2014, which regulates the academic internship of university students, and the UAB regulations of external academic internship, approved by the UAB Governing Council Agreement of December 10, 2014) considers them a university-supervised training activity, whose objective is to allow students to apply and complement the knowledge acquired in their academic training, favoring the acquisition of skills that prepare them for the exercise of professional activities, facilitate their employability and promote their entrepreneurship.

## The Biosciences model

- ✓ The teacher responsible for the academic internship in institutions is responsible for establishing contacts with the collaborating institutions and for distributing the places upon request of the student.
- ✓ Students who wish to do academic practices in institutions must have passed the first course and 120 credits of the first three courses, must enroll in the corresponding subject and pay the corresponding supplementary insurance fee before the start of the stay.

The supplementary insurance is a service offered by the university consisting ins an accident insurance, travel assistance and public liability addressed to the entire group of students enrolled in the UAB.

- ✓ The student's stay in the institution will be of 280 hours and will not mean the establishment of any employment relationship between the institution and the student.
- ✓ According to what is determined by the "Real Decreto" and on the proposal of the Faculty of Biosciences, the two institutions will sign a specific agreement for educational cooperation that establishes the terms of the conditions to accommodate each student.
- ✓ The collaborating institution will name a tutor who, together with the teacher responsible for the subject, or the academic tutor he / she will name, will follow the students during the stay.

The tutor of the collaborating institution will send by e-mail to the responsible of the subject a final report within fifteen days following the end of the stay. The report model is available in excel format on the Faculty website.
